### Agreements

Oranim Educational Initiatives, 28 Ha'taas St., Kfar Saba, Israel, and 5035 Mayfield Rd, Lyndhurst, OH 44124 is responsible to you in making arrangements for the tour services offered, including transportation, sightseeing, and hotel accommodations. The carriers, hotels, and other suppliers providing tour services are independent contractors and are not agents, employees, or servants of, or joint ventures with the Organization or its affiliates. All certificates and other travel documents for tour services issued by the Organization are subject to the terms and conditions specified by the supplier and to the laws of the countries in which the services are supplied. The Organization reserves the right to accept or reject any person as a tour participant, to expel any tour participant from the tour, to make changes in the itinerary whenever the Organization deems it necessary for the comfort, convenience, or safety of the tour participants, and to cancel a tour at any time. The tour participant agrees that neither the Organization nor its affiliates shall be liable for any damage, loss (including personal injury, death, and property loss) or expense occasioned by any act or omission of any supplier providing tour services, or any insurer or insurance administrator of the Travel Protection Plan, or of any other person. Legal proceedings against the Organization may be instituted only in a court within the State of Israel, and any claim involved in such proceedings shall be decided in accordance with the laws of the State of Israel. Any legal proceedings against the Organization must be commenced within one year following the date of tour completion. Neither the Organization nor any affiliate shall in any case be liable for other than compensatory damages, and you hereby waive any right to punitive damages. The participants' parents, as legal representatives waive any rights regarding use of images taken during the trip, even if used by Oranim commercially. No person, other than an authorized representative of the Organization by a document in writing, is authorized to vary, add, or waive any term or condition in this offer, including any term or condition set forth in the preceding provisions. This tour may involve hazards incident to travel in undeveloped areas including those arising from political unrest, poor security and safety conditions and limited medical and evacuation facilities in case of illness or accident. We will make reasonable efforts to limit the hazards but neither the Organization nor its affiliates assumes liability for damage, loss or expense arising from such hazards.
